

**Fall Plant Sale – GROWvember, 2017  
Policies and Procedures**

**GENERAL**

The Plant Sale will occur on Friday, November 3<sup>rd</sup>, starting at 1:00 pm, and going through the Preview Party, which will end at approximately 6:30 pm. On Saturday, November 4<sup>th</sup>, the Sale will be open from 8:00 am to 4:00 pm.

Set-up must be completed by noon on Friday, November 3<sup>rd</sup>, for opening at 1:00 pm. The Garden will be patrolled during the night on Friday.

Take-down starts at 4:00 – 5:00 pm, on Saturday, November 4<sup>th</sup>, and must be completed by 7:00 pm. Daylight Savings Time ends at 2:00 am on November 5<sup>th</sup>, which means that sunset will be at 6:37 pm on the 4<sup>th</sup>.

Due to safety and health regulations, no dogs or other pets shall be allowed in the Plant Sale area.

**VENDOR RULES**

A. Parking shall be provided for one truck/trailer per vendor for the duration of the Sale. Vendors are limited to a vehicle with a weight of 1.5 tons or less. The vehicle may be used as a holding area. Mead Botanical Garden reserves the right to limit vehicle access and to direct traffic in such manner as it may determine necessary.

B. Vendors are required to provide tables, chairs, display racks, extension cords, garden hoses and other items as necessary or appropriate to make an attractive display area.

C. Extension cords and garden hoses must not extend over walking paths and must be placed in a manner to ensure safe operation and safe access to vendor booths by pedestrians.

D. Mead Botanical Garden reserves the right to relocate vendors within the space and to limit the quantity of space leased to any vendor.

E. Vendors are responsible for staffing booths for the duration of the Sale, from 1:00 to 6:30 pm on Friday, November 3<sup>rd</sup>, and from 8:00 am to 4:00 pm, on Saturday, November 4<sup>th</sup>.

F. Display area/booths must be maintained in a clean and organized fashion.

G. Vendors are responsible for cleanup in the vicinity of their operations.

H. Trash must be removed from Mead Botanical Garden or, alternatively, reasonably small amounts of trash may be placed in the trash receptacles found throughout Mead Garden. In no event shall Vendors cause the overflow of trash receptacles.

I. Vendors must sell at retail pricing during the sale. No wholesale operations may be conducted at this Plant Sale.

J. Vendors must collect and remit 6.5% Florida Sales Tax in accordance with applicable laws and regulations.

OTHER ITEMS PROVIDED BY MEAD BOTANICAL GARDEN, INC.

A. An approximately 25' X 25' area of land, which may include trees, shall be provided for each Vendor's use from 7:45 a.m. on Friday, November 3, 2017 through 7:00 p.m. on Saturday, November 4, 2017; provided, however, that sales may occur only during the hours of 1:00 to 7:00 p.m. on Friday, and 8:00 a.m. to 4:00 p.m. on Saturday, and further that all set up must be completed by Noon p.m. on Friday.

B. Booth assignments shall be made upon submission of fully completed forms and full payment.

C. Booth assignments may be revoked for failure to comply with these policies and procedures.

D. Access to water and electricity will be provided to the extent available in the park. Vendors should note on their registration forms any special needs.

E. A map showing the location and assignment of booths will be available at check-in.

F. Drive through for set-up and un-loading, provided however, Mead Botanical Garden reserves the right to limit access by large trucks and to direct traffic in such manner as it may determine necessary.

G. Night security by patrol will be provided from 6:30 pm on Friday, November 3<sup>rd</sup>, through 8:00 am on Saturday, November 4<sup>th</sup>, 2017.
